RULES & REGULATIONS:

Entries will not be accepted from individuals having business licenses, business cards or otherwise indicating that they are in the business of selling art glass; nor from those employed by an art glass store or studio. Pieces entered in the show will not be for sale to the public and will not have prices on them. No work that has been electroplated will be accepted. All entries must be delivered assembled, clean and ready for hanging. All panels must be able to be hung from display racks. Entry must have been fabricated between January 1, 2009, and March 31, 2010. Entry fee is \$5.00 per entry and is payable at the time the application is filed. You may enter as many categories as you wish, but you are limited to only one entry per category. Although we will take every care in the handling of entries and will have staff on site during show hours The Stained Glass Shop accepts no responsibility for any damage that may occur during the show. The size of your piece cannot exceed 6 square feet.

DEADLINES:

Applications must be filed no later than 5 PM, March 30th, 2010. We will be preparing show tags for all entries, so all applications must be filed on time. Entrants will be responsible for delivery and pick-up to and from The Stained Glass Shop. Delivery hours are 1 PM to 5 PM April 24, 2010. Please bring your entry to the back door of The Stained Glass Shop; the staff will help you with unloading and checking in. Delivery times must be strictly adhered to in order to have the show ready to be judged April 26th. There will be a reception and presentation of awards at 1 PM on May 1st and pick-up will follow immediately. The Stained Glass Shop will close at 5 PM, so all entries must be picked up by then, or you must make arrangements for late pick-up when you deliver your entry. If someone else is picking up your entry, you must advise us ahead of time or we will not release it.

JUDGING CRITERIA / PRIMARY CONSIDERATIONS:

1) Glass use: creativity in glass choices, i.e. textures and striations used to achieve special effects; unusual use of color or type of glass; unusual/creative techniques. 2) Presentation: framing, display, etc. 3) Proper fabrication: Copper foil: soldering must be clean, smooth, rounded and consistent. Lead construction: lead came must be smooth with no fabrication scars, solder joints smooth and blended; panel should be clean and free of excess putty. 4) Deductions will be taken for broken pieces.
